

FAQ's for RM-10[®] ULTRA - May 2006



Q: What is RM-10[®] ULTRA?

RM-10[®] ULTRA is the ultimate immune health formula, containing organically grown tonic mushrooms and other specially selected ingredients that provide broad spectrum immune support via multiple pathways: immune cell function support, immune cell metabolism support, methylation support and antioxidant support. †

Q: How is RM-10[®] ULTRA different from existing RM-10[®]?

A: Both products contain tonic mushrooms that have been specially selected for their superior genetic heritage and then carefully cultivated to ensure that they maintain their integrity and potency. RM-10[®] ULTRA additionally contains clinically studied Maitake Gold 404[®] Maitake Extract along with a DNA Methylation Complex and an Immune Support Blend with important fermented ingredients. RM-10[®] ULTRA is packaged in the BioProtect[™] Packaging system and comes in UltraZorbe[™] capsules.

Q: What are the key ingredients in the new blends in RM-10[®] ULTRA?

A: The Immune Support Blend contains Poten-Zyme[™] (fermented) ingredients including Selenium. Other ingredients include Suntheanine[®] (L-Theanine), IP6, Broccoli Sprouts and Lycopene. The DNA methylation complex contains Betaine, Poten-Zyme[™] vitamin B12, Poten-Zyme[™] Folic acid and naturally occurring Methionine (from fermented ingredients). These ingredients were carefully selected for their immune support benefits.

Q: What is Suntheanine (L-Theanine) and why is it beneficial?

A: RM-10[®] ULTRA contains L-Theanine a natural amino acid naturally fermented from green tea. L-Theanine provides support for healthy gamma delta T cell presence in the body, important for proper immune function and host defense. †

Q: Why is Selenium important?

A: Some scientific evidence suggests that consumption of Selenium may reduce the risk of certain forms of cancer; however, FDA has determined that this evidence is limited and not conclusive. Selenium also helps to maintain optimal glutathione production, an important factor in immune health. †

Q: What is IP6 and why is it beneficial?

A: Inositol hexaphosphate (IP6) is a natural antioxidant component of fiber-rich foods such as whole grains and legumes and is found in almost every cell of the body.

Q: What is DNA methylation and why is it important?

A: DNA methylation is a normal biochemical process that occurs in the body, it is important in regulating cell identity and growth. RM-10[®] ULTRA contains a full range of nutrients that support healthy DNA methylation, a requirement for optimal health. † These nutrients with: betaine, Poten-Zyme vitamin B₁₂ and folic acid, all play a critical role in normal methylation by supporting the body's conversion of homocysteine into methionine, a key donor to cellular methylation. †
